The Clerk reported on an issue that had arisen at the Cemetery and a letter that had been received from Wallace Stuart Funeral Directors. After discussion it was **resolved:** that although the Council was not at fault, taking account of the distress caused to the affected family, the request from the Funeral Director should be agreed, and that this course of action be formally recommended to Council. Cllr Barham asked for information on the SID readings for North Newton, and Cllr Phillips updated members on the new cycle track planning application, mobile library issues, problems with drains on Champion Way and actions that the Stockmoor and Wilstock Residents' Association were taking to obtain funding for a Development Worker. Cllr Taylor reported that dredging works in the Moorland area were now scheduled for October. Members asked the Clerk to write to Mr Gumpster at the Environment Agency to explain the reasons for the timing and to Bloor and Persimmon Homes about the drain problem.
